



Attendance: Regular attendance ensures quality instruction for all students. Excessive absences will negatively impact your child as well as other students in class and therefore excessive absences from weekly classes and/or missing any of the mandatory rehearsals, including the staging run through on recital day, may result in your child not being permitted to perform in the annual recital. In the event this occurs, no refund for tuition, costumes and/or other associated recital fees will be issued. The two-week period preceding recital is mandatory for all performers.

Student Code of Conduct: ATT students are expected to act kind and respectful towards others at all times. Harming or threatening others, degrading comments, and any general display of disrespectful behavior (in the studio and/or on social media) will not be tolerated and may result in removal from the studio. Students are expected to listen and focus in all classes. Socializing/talking during instructional time causes distraction and will not be tolerated. Students should practice ONLY the technique and dance steps specific to the class they are participating in. Cell phone use during class is not allowed. Ringers should be turned off, and phones and watches should be stored in students' dance bags.

Food and Drink: Absolutely no eating during dance class! Snacks eaten in between classes should be eaten outside...never on the open dance floor! No open drink containers are allowed inside the dance studio. Water bottles with secure lids, straws, etc. are permitted.

Classroom Observation Policy: Visitors in the classroom can be a distraction to dancers and in some cases cause students to withdraw from full participation in their class. Doors will typically be closed during class. Parent Watch Week is scheduled regularly throughout the year and is a wonderful opportunity for parents to observe!

Recital Costumes/Recital Fee/Tickets: (applicable ONLY if participating in recital)
Costumes typically range in price from \$70-\$95 per dance. All costume fees are non-refundable. A recital fee is charged for every student participating in the annual recital. Recital fee is typically between \$50-\$75 per dancer. Tickets go on sale for the annual recital in May.

Parking and Drop-off/Pick-up:

NORTH Campus: When dropping off or picking up dancers, please use the parking spots located on the north side of the building closest to the stairs and ATTD entrance. Students may use the stairs to enter the ATTD doors. Teen drivers attending classes that let out after dark are asked to park at the drop off curb and exit together.

SOUTH Campus: Parking is available nearest the ATT entrance.

Pop's Cafe and Facilities: ATT students, and their families, are expected to respect all rules and regulations of LMCA. Pop's Cafe is open for all students and their families during the week. Please refrain from walking around the campus in dance clothes. Students must wear appropriate attire while walking around the facility outside of class time. Children under 10-years-old MUST be supervised while on campus.



Pricing & Tuition Agreements

- Registration fees are applicable at time of initial registration and at the start of each dance season thereafter.
- All registration fees are non-refundable/non-transferable.
- If written notice is not received at least 30-days prior to the start of the student's last month, tuition will have to be paid in full whether or not the student attends the full month. If written notice is not received at least seven days prior to the start of the student's last month, tuition will have to be paid in full whether or not the student attends the full month.
- Initial payment (registration fee + first month) will be charged once the online registration is processed and the required Automatic Payment Policy Form is received. Registration, including initial payment, is not complete until payment is successfully processed.
- Following the initial charges, at time of registration, all ATT accounts are set up on automatic payments. Automatic payments process on the 1st Friday of each month.
- For current customers adding additional classes and/or students to their account, all fees related to adding classes will be charged to the credit/debit card on file at the time changes are processed.
- In the event an auto payment is not successfully processed, for any reason, the student will not be permitted to further participate until the account is brought current. If the account remains delinquent after 5 days, a \$50 late fee will be assessed. An automatic reattempt will occur 5 business days after the failure.
- Monthly tuition remains the same throughout the season regardless of how many weeks fall in a month.
- Monthly tuition for new students registering mid month will be prorated at a rate of \$15/class up to 3 classes.
- All tuition is non-refundable/non-transferable.
- There are no refunds or credits for missed classes due to injury, illness, vacations, etc.
- Make-up classes are permitted, but not guaranteed. All make-up classes must be scheduled in advance and within 30 days of returning from the absence.
- Single class/DROP-IN fee is \$15 per class and must be pre-paid each time a student attends a class. Not all classes are open to drop-in attendance.

In addition to tuition payments, the following expenses also apply throughout the dance season:

Registration Fees: \$45.00 per student (due at the time of registration)

Costumes: Range from \$60-\$95 per dance (January/February)

Nutcracker/Recital Fee: \$75-\$185 per child (September/January)

Tickets for Performances: \$10-\$17 per ticket (December/May/June)
